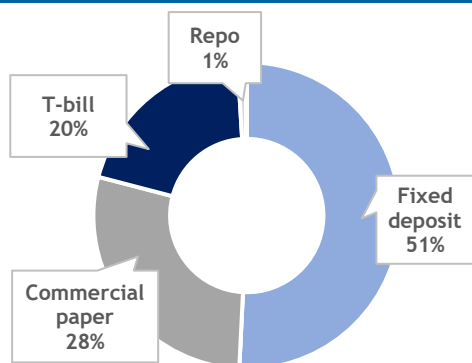

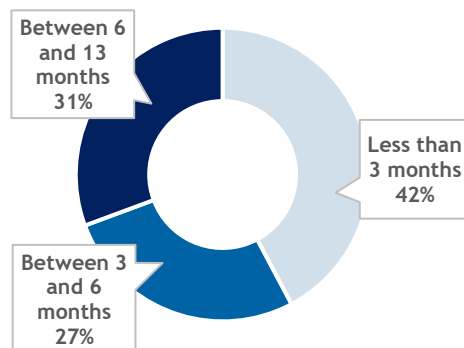

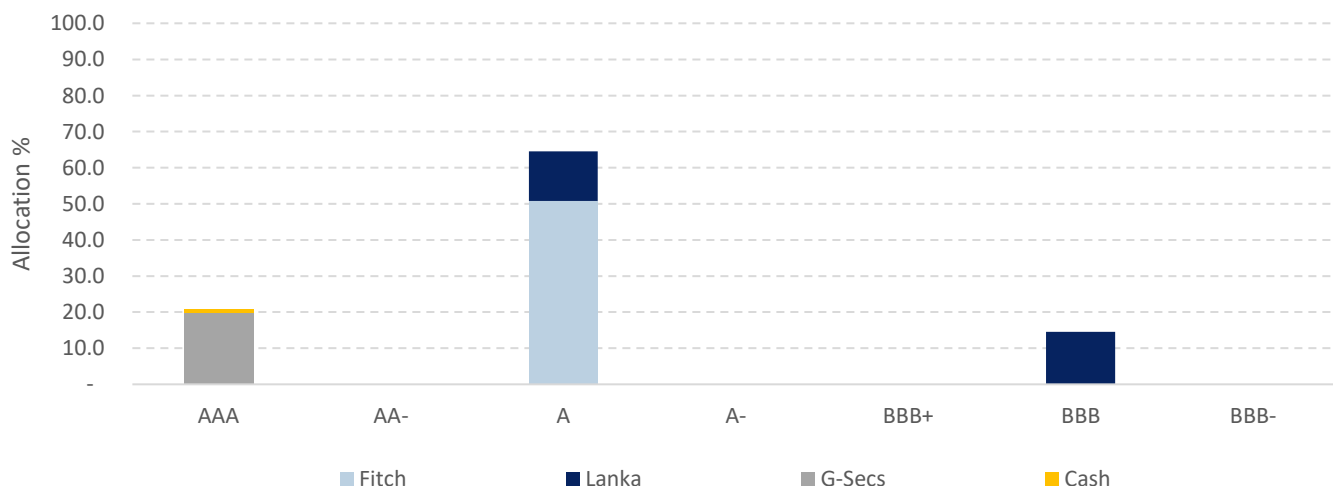
ASSET ALLOCATION²
