Intended for: Medium term investors with low/medium risk tolerance seeking capital growth and higher interest income compared to "A" rated bank deposits

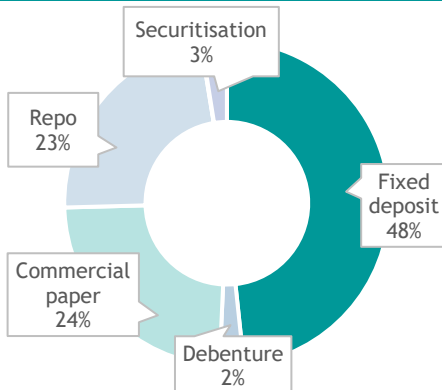

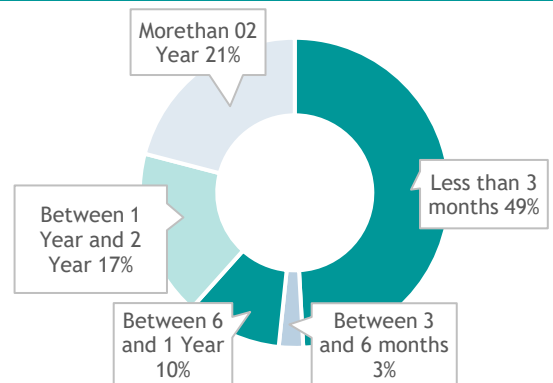

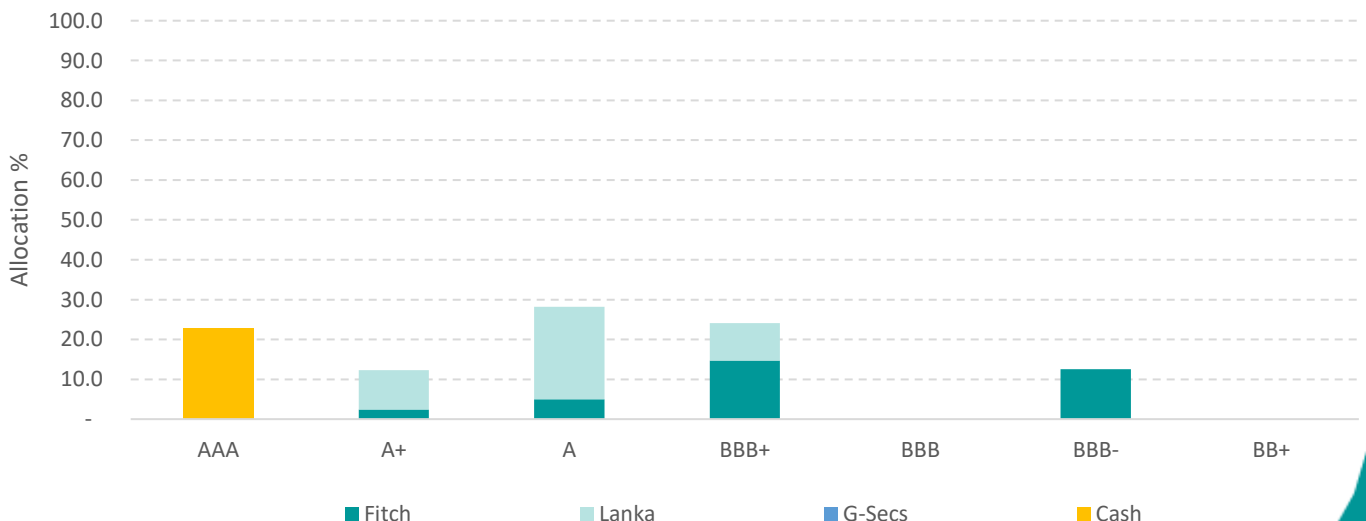
ASSET ALLOCATION²
